Ms. Schoenlein asked for more information regarding expenses that were captured in the Facility cost for the IHJA Annual Show. Ms. Vaught reported that the cost of the facility, port-a-potty rental and cleaning, and a golf cart were included in the Facility cost.

Ms. Willock asked for more information about the cost of Medal Finals and the revenue generated from Medal Finals Entry fees. The total cost of prizes was \$612. Revenue generated from Medal Finals Entry fees was \$1600.

Ms. Schoelein made a motion to approve the financial report. Ms. Willock seconded the motion. **The motion was passed unanimously.**

OLD BUSINESS

Annual Show/ Medal Finals

- TIP Application for 2024 Annual Show has been submitted.
- 2023 Annual Show and Medal Finals Review:
 - 2023 Annual Show was successful overall
 - Thank you to Ms. Heim for securing sponsorships, thank you to Ms. Vaught for work in the show office.
- Medal Final numbers were down overall, however the 2' Medal Final was very successful.
 How should we proceed moving forward?
 - Horse quality and type: Majority of available horses are more suited to jumper events.
 - Height: Majority of entries at local shows are competing at 2'6" and below.
 - O How to incentivize participating in a qualifier class?
 - Should we reorganize what classes are offered?
 - o Should we offer something different, like an Equitation Challenge.
 - Ms. Schoenlein and Ms. Whitaker agreed to work together on a written proposal for changes to 2024 Medal Finals for the 2024 Rule book, focusing on changes to medals above 2'6".
 - Ms. Vaught agreed to send a survey to membership regarding medal finals.
 - Ms. Willock suggested at the Annual Show that it would be nice to have additional placings available. After discussion, it was decided to award placings through 12th place and to have participation ribbons to award for participants beyond 12. Ms. Vaught also agreed to investigate cost of neck ribbons with the possibility of offering different ribbons at future events.
 - Elements of Medal Finals and order of events was discussed. Ms. Schoelein suggested that we might consider eliminating the flat phase. Ms. Zirkelbach asked about running the flat phase first. Ms. Stumm stated that the IHJA Rule Book requires that the fences run first for Medal Finals, and if we wanted to change it for the future, it would need to be submitted as a rule change. Ms. Vaught stated that, for Finals, it is nice to have the flat last for the purposes of presenting awards; during the Annual Show, the Hunter Derby was ran throughout the show and there was a mad scramble to get the participants and their horses back to the ring to present awards. Ms. Ochoa stated that at a recent WEC show, only the top 3 Derby finalists were required to return for awards. Ms. Zirklebach clarified that she was inquiring about qualifier flats run first Ms. Stumm stated that "flat first" is currently stated as a preference in the IHJA Rule Book.

NEW BUSINESS

The IHJA Board reviewed the complaint and agreed to send a letter to the trainer requesting a written response and to not award points to either the entered horse or the showed horse for that horse show.
